

Fitting Instructions for RAD0102BK/TI Radiator Guard HONDA CBF600 2011



In This Kit There Should Be
1x Radiator Guard (RAD0102BK)
2 x Cable/Zip Tie
2x 100mm Lengths of self adhesive Foam





- To fit the radiator guard to the bike cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame, so that they sit between the radiator guard and the radiator.
- Undo and remove both upper radiator-mounting bolts shown in picture above left.
- Offer the radiator guard into position and using original upper bolts secure the guard and radiator into
 position.
- Using the two cable/zip ties secure the guard into position in two places as shown above right.
- Tighten all bolts.

Instructions de montage RAD0102BK/TI Grille de protection radiateur HONDA CBF600 2011



Ce kit doit contenir:

1x Grille de protection radiateur (RAD0102BK) 2 x Câble / Attache câble 2x 100mm Longueurs de mousse adhésive.





- Pour installer la grille radiateur sur la moto, couper la mousse en bandeaux de 10mm et collez-les au bas de la protection radiateur pour que les bandeaux soient entre la protection et le radiateur.
- Desserrer et enlever les 2 boulons de fixation sur le dessus du radiateur (Photo en haut à gauche).
- Mettre la grille de protection en place et en utilisant les 2 boulons d'origine du dessus, fixer la protection et le radiateur en position.
- En utilisant les 2 câbles / Attaches câble, fixer la protection en position en 2 endroits (photo en haut à droite).
- Serrer les boulons.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
